HOPE'S Contribution

HOPE Hospital – Providing secondary healthcare services to the homeless, street and slum dwellers. The Hospital, established in 2008, works closely with eighty-five local charities that operate in Kolkata and its surrounding districts.

HOPE Hospital endeavours to ensure proper medical treatment of underprivileged people living below the poverty-line (A 4-member family earning less than INR 6000 (€92) a month is considered as "below poverty line"

Private healthcare is responsible for most of the healthcare in India. Public healthcare is free under The Indian Constitution for those below the poverty line, but limited resources, staff, medicine, and very long waiting lists make it very difficult for public healthcare users to get the help they need. Charities all face the same problem: inability to admit patients in State hospitals, often due to their street living and lack of identifying documents.

A charity must provide an Ayah (male/female attendant) to the State hospital when admitting a patient, to care for the patient's daily needs. A charity admitting a patient without a family must visit the hospital and pharmacy every day to ensure their patient receives adequate medication. This can become difficult, time-consuming, and expensive.

HOPE Hospital helps those who would otherwise be deprived of necessary medical treatment. This is achieved through the following strategic objectives:

- Ensure homeless, street and slum dwelling individual's rights to secondary healthcare without undue financial burden.
- Provide specialist care for in-patients/out-patients
- Provide surgery for homeless, street and slum dwellers at an affordable cost.
- Provide rehabilitation to homeless children and elderly after treatment in HOPE Hospital.

The charities support HOPE to ensure that no individual is returned to live on the streets after treatment at HOPE Hospital

Initially starting with just 5 doctors and 10 staff in a Polyclinic & Diagnostic centre (X-Ray &





Pathology) in 2008, the Hospital has grown to now employ 60 staff and 40 panelled doctors

Number of beneficiaries of HOPE Hospital: Over 11,500 patients per year. From its inception in 2008, more than 130,000 people have benefited through HOPE Hospitals varied services.

The Hospital has an Intensive Care Unit, Out-Patient Department, Diagnostics Centre, Surgical Department, and HOPE Pharmacy.

Let's get started!

Part 1 of the programme involves fundraising and raising awareness about HOPE within your local communities.

The fundraising element of the programme is very hard work. It requires a very good fundraising plan, excellent organizational skills, and a commitment to remain motivated and driven throughout your HOPE journey.

Participants will be fundraising publicly for HOPE but can also fundraise privately for private costs.

Public Fundraising target

Fundraising target: **€2400** Where does this go?

- €2000: HOPE's 60+ projects working with the street and slum children of Kolkata and their families and communities.
- €400: Morning/evening meal and accommodation, transport in Kolkata and drinking water.

Anything with a HOPE logo or advertised publicly in HOPE'S name is a public event and must legally be lodged to The HOPE Foundation.

Private Costs


Private costs are not lodged to HOPE.

You can fundraise to help cover your private costs, but under charity legislation you <u>cannot fundraise</u> <u>from the public to cover private costs</u>. Examples of private fundraising include donations from family and friends, private closed events at home (dinner party, games night), and a personal contribution (part time work, household chores, babysitting etc.)

- **Flights** approx. €1,200. HOPE will advise when this payment is required, and payment is organised by the fundraiser directly to the travel agent.
- Vaccinations approx. €150 *depends on the individual and their medical/vaccination history.
- Travel to and from Dublin airport
- Visa Application Fee approx. €30
- Independent Travel Insurance approx. €35 (Please Include COVID Cover)
- Spending money €200 max.

Making a lodgement to HOPE

- 1. Ensure you write your name and school at the bottom of the lodgement slip
- 2. Email your HOPE point of contact with your <u>name, school, amount,</u> and <u>date lodged</u>.

- You can lodge money into any AIB branch in Ireland. (We do not accept cash in HOPE office)
- You will receive an **electronic receipt** for lodgements. If you do not receive a receipt within 2 weeks of lodgement, please get in touch.
- Keep a <u>HOPE Folder</u> of your lodgement history, as well as any invoices for chocolates.
- Submit your fundraised money ASAP after raising it. Publicly raised funds are not allowed in a personal bank account.
- A student wishing to help another student may transfer surplus funds from their account with written consent from a parent only.
- All funds submitted are non-refundable

Meeting your fundraising Target

Your public fundraising target of €2400 needs to be lodged to your HOPE account at least 2 weeks in advance of your departure date.

When the balance of your flight is due (about 2 months before departure), we will ask participants to seriously think about whether their target will be met on time.

Where it is felt that the fundraising target of €2400 will not be reached, HOPE can carry over your fundraising balance to the following year. This will allow you extra fundraising time, and you can participate on next year's Immersion Programme.

If you choose to pay for your flights and the target is not met, you will unfortunately not be cleared to participate on the programme for that year, and flight payment will be lost.

A Note on Visa and Passport

Passports – It is your responsibility to ensure your passport has a minimum of 6 months' validity after the date of return from Kolkata

Visas – Are an online application process and can only be undertaken 30 days prior to travel.

FUNDRAISING IDEAS-LET'S GET PLANNING!

It is **SO IMPORTANT** to have a fundraising plan. Below is a breakdown of the work that goes into some fundraising ideas. It will help you make sure to plan and organize all activities in advance.

Collection Buckets

HOPE have a limited number of Collection buckets that can be loaned for a particular event.

If you are not close to our Cork or Dublin office, you can source your own collection buckets via your local supermarket/shop deli counters. **Buckets MUST be sealed with a lid and have a HOPE label**.

HOPE Letter of Authorization

Upon sign up, you will receive a HOPE letter of authorization which proves that you are an authorized fundraiser for HOPE. It is very important to always have this with you for fundraising, as well as asking for donations, sponsorship, or to hold an event.

Further materials to support with fundraising

HOPE T-Shirts- Participants receive six t-shirts free of charge upon signing up to fundraise for HOPE. Additional t-shirts can be purchased for €4 each. These t-shirts must be worn every day in Kolkata.

HOPE Bucket labels- All buckets used for collecting money at events and for selling chocolates MUST have a HOPE bucket label attached. Buckets must also have lids and be sealed shut with tape.

HOPE Sponsorship Cards -These 40-line cards can be personalised with your name and/or event and are ideal for collecting sponsorship.

HOPE Posters- You may also design your own posters for your events and use the HOPE logo

HOPE Thank You Cards- It is important to us that all fundraisers thank their donors personally. In certain circumstances, the HOPE office can supply individual letters/receipts.

HOPE Awareness – Make sure to keep up to date with HOPE on our Social Media, as well as check in with the HOPE website so you are well equipped to answer questions on HOPE's work

1. **HOPE Public Liability Insurance** A copy is provided to all our fundraisers and covers most usual fundraising activities. Please discuss your fundraising ideas with HOPE as not all activities are covered and additional insurance may be required

Ideas

SUPERMARKET BAG PACK

What do I need to do? Ask the manager of your local supermarket for permission to bring in a team to pack customers bags and have a collection bucket on each till. You will need:

- To secure an available date.
- Enough people to cover each till
- HOPE t-shirts
- Sealed collection buckets labelled with HOPE labels
- Details of HOPE's public liability insurance cover

RAFFLES AT EVENTS

A raffle is a great way to utilize an event you are already having. They can be held at coffee mornings, parties (dinner parties, fancy dress etc.), fun runs, golf tournaments, concerts, pub quizzes, and race nights - the list goes on!

What do I need to do? Contact local businesses or friends/family members to help you source a prize. Individualize letters/emails of request.

Important to note: A Garda permit is required when raffle tickets are to be sold in advance of an event.

SPONSORSHIP OF AN ACTIVITY

What do I need to do? Uundertake a 'challenge', e.g. running race, hillwalking climb, cycle, head shave. Do some research into any events that may be coming up? Get advertising and have HOPE sponsorship cards at the ready.

CORPORATE SPONSORSHIP

What do I need to do? Approach any business or companies that have Corporate Social Responsibility programmes, or who you believe may be open to offering a donation.

We can provide a receipt and thank you letter to the business. Some businesses are happy to help but need lots of notice for the donation to be approved. If you would like to explore corporate sponsorship as a method of fundraising, get in touch with your contacts ASAP.

Online Fundraising

The online fundraising tool, **idonate.ie** is great way to fundraise. The Hope Foundation is a registered charity with this platform. This means that when you set up an account and choose HOPE as the recipient, lodged funds will go directly to HOPE.

How idonate.ie Fundraiser's work

It only takes a few minutes to create a fundraising page on iDonate.ie. You can create a page for any cause registered with iDonate.ie

- 1. Go to https://www.idonate.ie/createfundraiser.php
- 2. Complete the details requested in each section
- 3. After completing, check your email for activation details.

Once you page is activated, you can start your fundraising immediately. iDonate.ie transfer the funds you raised direct to your chosen cause month to month.

What fees do iDonate charge?

Credit Card / Debit Card - 1%

PayPal - 1.9% + €0.35

Stripe / Apple Pay / Google Pay - 1.4% + €0.25

iDonate has a platform / admin charge of 4%. This allows them to provide a professional service to causes. Donors are given the option to cover the fees, which 75% of donors opt to do. This results in the cause getting 100% of the donation amount. All donations are transferred directly to each cause

HOPE Merchandise

The HOPE office keeps items in stock that can be used by fundraisers for their *public* fundraising activities. For a further overview, visit The HOPE Shop on our website, or give the HOPE office a call.

Invoice/sale price = €10. Entire €10 allocated to student's account.



Handmade Peacock Cards

Our peacock cards are handmade by underprivileged women on our Life Skills Programme. Two cards in a pack. Sale price = €4. The cost price per pack is €1.40, which means €2.60 profit is allocated.



HOPE Butlers chocolate bars

HOPE has a delicious, high-quality charity chocolate bar that are manufactured by Butlers Irish Chocolate with a customised wrapper. €2.00 per bar.

*HOPE hoodies are available to purchase before travel, or for fundraising in the cold months! Price: €25

Ordering Chocolates

You can order chocolates by:

• Emailing the office on office@hopefoundation.ie.

When ordering, please give all the following details:

- Your Name and School
- How many cases are required (1 case = 80 bars)
- Whether you are collecting from the office or would like delivery (Eircode needed)

HOPE Chocolate bars explained

Each case of chocolate contains 80 bars (4 small boxes of 20 bars). For each case ordered, you will be invoiced for €200. You will sell each bar for €2.00. (80 bars x €2.00 each = €160). For every bar sold, €0.60 goes to pay the cost of the bar to Butlers, and the remaining €1.40 goes towards your fundraising total. For every case sold, and every €160 returned to HOPE, €112 of this will count towards your fundraising money and €48 is retained as cost.





Important points about chocolate

- Chocolates must be paid for, or returned, within **2 months** of ordering.
- When you owe for chocolates any lodgements made to HOPE will be used to pay them off as soon as possible. E.g. If you lodge money from a bake sale, the amount will pay off chocolates.
- Chocolates are invoiced to the individual. Do not give/lend chocolates to another student.
- The maximum order for chocolates is 2 cases. No further chocolates can be ordered unless outstanding chocolate has been paid for.
- There is a delivery charge of €10 for up to 6 cases .2 students can order 8 cases to one address for no delivery charge.
- Bars should be **stored** in a cool location, away from heaters. Bars should also be kept away from potential rodent attack (in your house/office etc is better than in an outside shed).
- Returned bars must be unopened, with cellophane still sealed, not damaged, wet, or out of date. The individual is responsible for delivering bars back to HOPE office.

Is a Permit Required to Sell Chocolates?

No a permit is **not required** when you are selling Butlers HOPE chocolate bars in public places. Under Section 2 of the Casual Trading Act, this is **not required** when selling items "that any profits there from are for use for charitable purposes or for other purposes from which no private profit is derived". Please refer anyone who may ask about this to your HOPE group leader.

A 'public place' is any area that is not privately owned and operated, and where the public have free access.

Selling without a permit is not automatically permitted in any location that can be considered **PRIVATE**, including Shopping centres, churches, inside stadium grounds/events.

Selling Chocolates in a Public Space-Important to Note

It is important to note that there should not be an overlap between selling chocolate bars publicly and bucket collecting when you have no permit. A permit is required for street collections and church gate collections.

Garda Permit Requirements

A **Garda permit** may be required in certain circumstances for fundraising. Permits are issued by **An Garda Siochana** under the Street and House to House Collection Act, 1962. For participants in Cork and Tipperary, permits are issued directly to HOPE. In this case contact your HOPE group leader and **not** your local Garda station.

Church Gate Collections

Church gate collection permits allow you to undertake a bucket collection **outside** the church gates on a specific date and location. Only a limited number of permits are available, please ask your HOPE group leader if there are any available in your parish. You may collect **inside** the church gates or host a cake sale **without** a permit but **only** if you have the permission of the priest.

Street Collections ("Flag Days")

These permits allow you to stand in a public place and collect donations from the public. A 'public place' is any area that is *not privately owned and operated, and where the public have free access*. Street collection permits are granted several times a year to HOPE and can **only** be used on the date stated on the permit. Certain conditions must be met, including not obstructing motor/pedestrian traffic or collecting from moving vehicles, not using loudspeakers or aggressively shaking buckets. The minimum age for collectors is 14 years. Buckets must be **sealed with a lid and clearly labelled with a HOPE label** (available from the office).

Raffles

No permit is required for a raffle as long as the **tickets are only sold at the event itself**. You cannot sell raffle tickets before the event, including door-to-door or leaving tickets in a local shop. If you wish to do this, you will require a Garda permit. There are only two permits per year allowed for HOPE for these purposes, so we ask that you restrict your raffles to small raffles at fundraising events only.

NB ***UNAUTHORIZED METHOD OF FUNDRAISING ***

An underage disco or ball is an unauthorized method of fundraising. If any such event is advertised in <u>HOPE's name</u> or <u>using HOPE's logo</u> we ask that it is reported to HOPE immediately.

Any student found to have held an underage disco or ball in HOPE's name may be required to withdraw their place on the programme.

HOPE Communication

Hope's primary method of communication is email. Please make sure you are keeping an eye on your email for receipts, updates, reminders etc...

HOPE is here to help and happy to assist throughout your HOPE journey. Please do not hesitate to give the office a call, or email with any questions, queries, or updates.

FREQUENTLY ASKED QUESTIONS

For students, parents/guardians, and teachers

Where Will Students Stay?

Students will reside in the HHI Hotel for the duration of their stay. The Hope Foundation has an ongoing relationship with the hotel, which is safe, secure, and value for money. Students will receive breakfast each morning and an evening meal each night (included). Lunch is an additional cost to the student, for example, lunch in the HOPE Life skills cafe is around €5. Private buses are used to take the group to and from the HOPE projects each day. Students remain in the hotel after dinner and activities are organised for the evenings within the hotel. Participating in the evening activities is optional, and the cost is additional but minimal (for example, sari draping costs around €3). Wi-Fi is available free of charge and we insist all students contact home each day.

Will Students Be Safe?

Students will be accompanied at all times by their Garda Vetted teachers/supervising adult and a HOPE group leader for the duration of their trip. Students are not permitted to travel anywhere unaccompanied and will remain in the hotel in the evening. At all times students will be on private buses for travel between projects and the hotel.

What Will The Group Do In Kolkata?

The Hope Foundation will design a full timetable for the group which will include visits to HOPE's education centres, the HOPE hospital and a visit to a slum community. There will also be tourist and cultural visits, including a city tour, Mother Theresa's former home, Jain Temple, Birla Temple and Dashkinipan Market for shopping. In the evenings we will be in the hotel, and activities including henna tattoo, Indian dance class and sari draping will be arranged.

Are There Group Meetings Prior To Travel?

A HOPE Representative will organise a parent/student orientation session upon receiving all applications. There will be ongoing email and phone contact with all group participants and their parents and schools. Finally, there will be a final meeting 8-12 weeks prior to departure to answer any questions and discuss Visa Applications and Departure details.

Will Students Be Exposed To Negative Conditions?

HOPE is very aware of the effects of over exposure to conditions within Kolkata's street and slum communities. We are guided by our own experience, our social workers and our ground staff in relation to age-appropriate exposures. Group meetings take place each evening and students are encouraged to speak about the day's activities, to explore their emotive responses and to seek additional supports if needed.

Is Medical Support Available?

Yes. We have our own HOPE hospital in Kolkata which is accessible 24/7 for all students and volunteers. There is a wide range of experienced medical professionals available for consultation.

BENEFITS FOR STUDENTS INVOLVED IN THE IMMERSION PROGRAMME

Story of Change - Joy

Joy was born in Maldah, West Bengal, but became an orphan at the age of 5. The people who cared for him were abusive and forced him to work in a tea stall. He was a victim of abuse at home and ran away after a couple of months by boarding a train heading to Kolkata. He was discovered by Railway Police and was admitted to a residential boarding home. All was going fine until he got into a fight at the age of 10 with his friends. Due to the strict rules in his school, he was expelled and moved to Purulia Ramakrishna Mission. Joy's world turned upside down and losing his newfound friends all of a sudden came as a big blow. He was extremely sorry for the incident and went through a lot of emotional turmoil and eventually left the school and began wandering the streets of Kolkata.

He arrived at Howrah train station but was entrapped by a group of people who promised to get him work in Andaman. He went to Andaman and spent several days alone until he was caught by the Police who mistook him for an immigrant and jailed him as he had no form of identification. He was eventually released and returned to Kolkata to Howrah train station once more to try and find some work or food to survive.

Joy was 14 years old when he was rescued from Howrah Railway Station by one of HOPE's social workers and his case was produced before Kolkata's Child Welfare Committee. Joy was then placed in HOPE's Ashirbad Boys Home for his care. Guided by the love and warmth of HOPE's team in Ashirbad, he was enrolled in a school and quickly became re-engaged in his studies.

Joy completed his schooling after completing his Class X Examinations. He has also sat the Polytechnic Examination from West Bengal State Council of Technical & Vocational Education and Skill Development and was placed in the top 8% of all those who took the exam in the state of West Bengal. Joy has already started a Diploma Course in Shantiniketan Polytechnic Institute and aspires to pursue a course in Mechanical or Electrical Engineering after completing his diploma.
